Last year, the National Labor Relations Board ordered Starbucks to stop violating workers' rights to organize, and is currently investigating systematic violations of workers' rights including firings, rescheduling union supporters, and interrogation and clandestine surveillance of workers in Grand Rapids and New York City. In California, Starbucks has been ordered to reimburse workers for millions of dollars in misappropriated tips.

In New York, Starbucks workers have won better wages and conditions over three years of union organizing efforts, despite the company's campaign of intimidation.

Starbucks claims to be a socially responsible company, but the facts prove otherwise. Not only does Starbucks systematically violate its own workers' rights, only a very small percentage of Starbucks coffee is certified Fair Trade – showing that their willful neglect of the coffee farmers supplying them beans is just as rampant as it is for the baristas serving their coffee.
